## Uniform Commercial Code Sec. 6105 (b)

(b) At least 12 business days before the date of the bulk sale, the notice shall be: (1) Recorded in the office of the county recorder in the county or counties in this state in which the tangible assets are located and, if different, in the county in which the seller is located. . . (2) Published at least once in a newspaper of general circulation published in the judicial district in this state in which the tangible assets are located and in the judicial district, if different, in which the seller is located. . . , if in either case there is one, and if there is none, then in a newspaper of general circulation in the county in which the judicial district is located. (3) Delivered or sent by registered or certified mail to the county tax collector in the county or counties in this state in which the tangible assets are located. If the tangible assets are located in more than one judicial district in this state, the publication required in paragraph (2) shall be in a newspaper of general circulation published in the judicial district in this state in which a greater portion of the tangible assets are located, on the date the notice is published, than in any other judicial district in this state and, if different, in the judicial district in which the seller is located. . . As used in this subdivision, "business day" means any day other than a Saturday, Sunday, or day observed as a holiday, by the state government.
